
# Never Again Coalition 2019 Annual Report

### **iACT**

well as the soccer Refugee
United Academies for refugee
boys and girls ages 6-13. The
youth academies improve onthe-field skills and off-the-field
peacebuilding efforts, while giving
girls equal opportunity, access,
and leadership tools.

### **Action Kivu**

I5 Portland-area restaurants and bakeries participated in the 6<sup>th</sup> annual Chocolate for Congo, done in partnership with Theo Chocolate. We raised \$2,500 for Action Kivu's entrepreneurial programs as well as their primary and secondary schools in eastern DRC.

## Legal Action Worldwide

Shirt sales from our our #HerToo campaign support LAW's work with Rohingya women in Bangladesh including the Shanti Mohila (Peace Women), a Rohingya survivor group in Bangaldesh, with their advocacy to ensure comprehensive victimcentered accountability and with psychosocial support.

### WHAT WE ACCOMPLISHED IN 2019

**AWARENESS** In April we organized and facilitated **Exiled to Nowhere: A Symposium on the Rohingya**. This 3-day event took place at the Oregon Historical Society in conjunction with a photo exhibit by Greg Constantine – Exiled to Nowhere: Burma's Rohingya. The symposium featured talks by genocide survivors, photojournalists, investigators and members of Portland's Rohingya community and was done in an effort to raise the profile of the Rohingya plight in our Pacfic NW community.

Other awareness events included film screenings: two films about the Rohingya – *Mother, Daughter, Sister* and *We Are Blood* as well as the film *Not Just Football* about the Darfur United Soccer Team. We organized talks including one by Professor Paul Slovic on Confronting Genocide and the Deadly Arithmetic of Compassion. Another included three perspectives on Kutupalong refugee camp in Bangaldesh, home to over one million Rohingya refugees.

**ENGAGEMENT** We're honored to continue and grow our connections with the Rohingya, Sudanese and Congolese communities in Portland. We joined all three of these communities for local meetings with the offices of Senators Merkley and Wyden as well as Representatives Blumenauer, Bonamici and Schrader.

We engaged the greater Portland community with events such as **Chocolate for Congo** and **iACT for Refugees**; by participating in Sudanese rallies to support the protests in Sudan, & at local events PDX World Refugee Day, Portlanders Stand with Refugees & Immigrants and the Walk with Refugees and Immigrants.

In an effort to broaden our connections, Never Again Coalition members attended the International Conference for Protection and Accountability in Burma and the Lemkin Summit to End Genocide and Mass Atrocities. NAC's Director, Lauren Fortgang, traveled to Bangladesh to visit the Rohingya refugee camps as part of a delegation by the Richardson Center for Global Engagement.

**ACTION and CHANGE** On both local and federal levels, we continue to engage with elected officials through the Postcard Brigade and through congressional meetings in Portland, Salem, and Washington DC. Our advocacy efforts paid off in a big way in 2019. In Oregon, we successfully introduced the **Conflict Mineral Procurement Bill** in the Oregon State Legislature. The bill passed the Legislature unanimously and was signed into law in June. Oregon is now the 3rd state in the country with a conflict mineral policy, significantly strengthening Oregon's contracting purchases to support businesses that comply with international guidelines in reference to how conflict minerals are sourced. We also partnered on introduction of the **Holocaust and Genocide Education Bill** in the Oregon Legislature. Now signed into law, the bill mandates Holocaust <u>and</u> genocide education in all Oregon public schools.

Our legislative efforts with U.S. Congressional offices saw many successes in 2019 as well. Some of the major achievements were both the **Elie Wiesel Genocide and Atrocities Prevention Act** (GAPA) and the **Global Fragility Act** (GFA) passing and being signed into law. GAPA requires training by US foreign services officers on conflict prevention, peacebuilding, and early action response. It also obligates the US government to mitigate threats to national security by taking practical steps towards atrocity prevention including an annual evaluation of at-risk countries. The GFA will create the first-ever comprehensive US government strategy to tackle and prevent spiraling global conflict. The House and Senate also both passed resolutions affirming **US recognition of the Armenian genocide**. \*\*Check out our 2019 Legislative Scorecard to see a record on all of the legislation we advocated for in this past year.
